# MINUTES LAFAYETTE COUNTY SCHOOL BOARD REGULAR MEETING, JUNE 15, 2021

The Lafayette County School Board convened in regular session, Tuesday, June 15, 2021 beginning at 6:00 p.m. Present were Mr. Robert Edwards, Superintendent of Schools; Mrs. Amanda Hickman, Chairperson; Ms. Marion McCray, Vice-Chair; Mr. Darren Driver, Member; Mr. Jeff Walker, Member; Mr. Taylor McGrew, Member; and Mrs. Leenette McMillan-Fredriksson, School Board Attorney. Administrators present were Mrs. Tammi Maund, Director of Finance; and Mr. Stephen Clark, LES Principal.

## **CALL TO ORDER**

Mrs. Amanda Hickman called the meeting to order at 6:00 p.m. Mr. Taylor McGrew gave the invocation and Superintendent Edwards led the Pledge to the Flag.

# **RECOGNITONS/PRESENTATIONS**

Jon Little, Director of Communications with Suwannee Valley Electric Cooperative (SVEC) made a presentation to the board presenting the Board with a copy of a check. The check represented what SVEC and its members have contributed to the teachers and classrooms within Lafayette County through their Operation Round Up program. SVEC established their Operation Round Up program in January of 2019. Members who participate in the program automatically have their monthly electric bills rounded up to the next dollar, with the extra amount going into SVEC's Operation Round Up fund. These funds are then put toward grants which directly benefit students in local classrooms. The amount raised for Lafayette County students and teachers, represented in the presentation of the check copy, was over \$44,000.
