MINUTES LAFAYETTE COUNTY SCHOOL BOARD REGULAR MEETING, AUGUST 16, 2016

The Lafayette County School Board convened in regular session, Tuesday, August 16, 2016 beginning at 6:00 p.m. Present were Mr. Robert Edwards, Superintendent of Schools; Mrs. Amanda Hickman, Chairperson; Mrs. Marion McCray, Vice-Chair; Mr. Darren Driver, Member; Mr. Jeff Walker, Member; Mr. Taylor McGrew, Member; and Ms. Leenette McMillan-Fredriksson, School Board Attorney.

CALL TO ORDER

Mrs. Amanda Hickman called the meeting to order at 6:00 p.m. Mr. Darren Driver gave the invocation and Superintendent Edwards led the Pledge to the Flag.

RECOGNITIONS/PRESENTATIONS

RESOLUTIONS — The School Board adopted Resolutions honoring the employees named below for their dedicated service to Lafayette School District:

1. ADOPTION OF AGENDA

Mrs. Hickman asked for a motion to adopt the agenda. On a motion by Mr. Darren Driver and a second by Mr. Taylor McGrew the agenda was unanimously adopted by the School Board.

Mr. McGrew expressed concern regarding the large number of individuals approved by the School Board each year to transport students. He asked how this is regulated. The requirements for someone to be approved to transport students were noted as follows: The driver must show proof of insurance coverage at the minimum limits required by Florida Statutes and at other limits that may be required by the School Board. The driver must provide proof of a valid driver's license and a satisfactory driver's license record check and must also be approved by the School Board. Mr. McGrew also asked if a parent is required to sign a consent form allowing their child to be transported to a school event by another parent or a school board employee. Superintendent Edwards stated that he would check on this to make sure all the requirements/procedures were being properly followed. Mr. Taylor McGrew moved to approve the consent agenda as recommended by Mr. Edwards. Mr. Darren Driver seconded the motion. The vote for approval was unanimous. These items are listed below:

Mr. Darren Driver moved to approve the 2015-2016 Annual School Health Services Report. Mrs. Marion McCray gave the second. The vote for approval was unanimous. - 4.04 **2016-2018 SCHOOL HEALTH SERVICES PLAN** The School Health Services Plan for 2016-2018, as prepared by Melissa Pearson, Community Health Nursing Supervisor, was presented for the Board's review and approval. Mr. Taylor McGrew moved to approve the 2016-2018 School Health Services Plan. Mr. Jeff Walker gave the second, which was unanimously approved. (School Health Services Plan on file in district office)

- 4.05 SHELTERING AGREEMENT WITH HOMEWOOD LODGE, ALF The School Board reviewed a Sheltering Agreement (Reciprocal Policy Agreement for Internal and Natural Disaster) between the School Board and Homewood Lodge, Assisted Living Facility. The agreement states that LCSB will provide assistance in the event of a natural or a man-made disaster in which Homewood Lodge, ALF is required to evacuate part or all of its residents. The agreement states that in the event of such an emergency, LCSB will provide temporary shelter and services for Homewood Lodge residents to the extent its resources will allow. Mr. Taylor McGrew moved to approve this agreement. Mr. Darren Driver gave the second. Motion carried unanimously. (Agreement on file in district office)
- 4.06 EMERGENCY TRANSPORTATION AGREEMENT WITH LAFAYETTE HEALTH CARE

CENTER — An Emergency Transportation Agreement between the School Board and Lafayette Health Care Center was presented for approval. The agreement states that Lafayette School District will provide transportation services, as able, for residents and staff of the Lafayette Health Care Center in the event there is a need to evacuate the facility. The agreement states that if possible, advance notice must be given prior to evacuation. The agreement also states that the School Board will bill Lafayette Health Care Center for its services at a per mile rate for transportation services that will include distance to the evacuation site and the distance to return from the evacuation site. Following discussion, Mrs. Marion McCray moved to approve the Emergency Transportation Agreement with Lafayette Health Care Center. Mr. Taylor McGrew gave the second. The vote for approval was unanimous. (Agreement on file in district office)

- 4.07 TEXTBOOK SELECTION FOR LHS A new textbook selection for LHS (*Physical Science: Concepts in Action developed by Prentice Hall*) was presented for the School Board's approval.
 A copy of the new textbook had been made available in the board room for board members to preview prior to the meeting. On a motion by Mrs. Marion McCray and a second by Mr. Jeff Walker, the new textbook selection was unanimously approved.
- 4.08 BILLS APPROVED FOR PAYMENT The bill list, as presented ready for payment, was unanimously approved on a motion by Mr. Jeff Walker and a second by Mrs. Marion McCray (Bill list on file with Supplemental Minutes)
- 4.09 **BUDGET AMENDMENTS** The following budget amendments were unanimously approved after a motion by Mrs. Marion McCray and a second by Mr. Jeff Walker: General Fund No. 7; Debt Service No. 1; and CO & DS No. 4.
